Administrative Reviews	Encourages the Secretary of Agriculture to return to five year inspection cycles for schools consistently complying with Federal standards.		Administrative Reviews. —The Committee understands the importance of the formal administrative reviews state agencies conduct as required by the Healthy, Hunger-Free Kids Act. However, the Committee encourages the Secretary to return to the 5-year inspection cycle for schools that consistently comply with Federal standards to allow state agencies more flexibility in performing their oversight and on-sight technical assistance roles. High-risk schools that do not consistently comply with Federal regulations should continue to be reviewed on a more frequent basis. The Committee also encourages FNS to assist state agencies in collaborating with one another when identifying risk factors to ensure that the administrative review process is effective and consistent nationwide. Equipment Grants	Authorizes \$30,000,000 for grants to State agencies, to be subgranted to local education agencies for: equipment purchases over \$1,000; serving healthier meals; improving food safety; or creating, maintaining, or expanding a breakfast program.	Provided further, That of the total amount available, \$30,000,000 shall be available to provide competitive grants to State agencies for subgrants to local educational agencies and schools to purchase the equipment, with a value of greater than \$1,000, needed to serve healthier meals, improve food safety, and to help support the establishment, maintenance, or expansion of the school breakfast program ^B	Provided further, That of the total amount available, \$30,000,000 shall be available to provide competitive grants to State agencies for subgrants to local educational agencies and schools to purchase the equipment, with a value of greater than \$1,000, needed to serve healthier meals, improve food safety, and to help support the establishment, maintenance, or expansion of the school breakfast program ^B	
	Encourages the Secretary of Agriculture to review current regulations on school meal patterns, including those dealing with serving dairy products and smart snacks, to ensure they maximize participation in programs, maintain healthy requirements, and do not impose additional costs on schools. It also encourages USDA to provide schools with flexibility to use leftover compliant foods in a manner consistent with	School Meals. —The Secretary has taken positive steps to provide greater flexibility and restore local control in serving healthy meals. The Committee urges the Secretary to review the regulations on school meals, including school meal patterns such as the requirements around serving dairy products, and smart snacks in schools that will ensure the regulations do not cost schools additional funding, maximizes participation, and maintains healthy requirements in schools. As a part of this review the Secretary shall look at research that is based on student-age individuals and shall consult with local stakeholders, including school superintendents, school board members, school leaders, and school food service personnel. Food waste also remains a concern in the school meals program. Schools should have the ability to serve leftover compliant foods in a quick, timely manner in accordance with food safety requirements. The Committee urges USDA to consider implementing flexibilities in allowing schools to utilize these foods in a

Paid Lunch Equity (Financial Management Tool)	Requests that the USDA's Food and Nutrition Service provide guidance for alternative tools for schools to assist in financial management documentation. Provides \$20,000,000 in	Financial Management Tools. —School food authorities would benefit from consolidating financial reports that are required in 7 CFR 210.19(a)(1). The tools that are available to help schools meet this requirement can be cumbersome. The Committee directs FNS to provide guidance within 60 days of enactment of this Act on the content of an alternative financial tool that schools may have in place for the purpose of providing the required financial management documentation.
