The SNA of SC Hall of Fame Awards is an opportunity to recognize the "difference makers" in our Child Nutrition Programs in South Carolina. If the nominee is retired, deceased, or is no longer employed, their contribution should be highlighted for the time they were a Child Nutrition employee and SNA of SC active member.

This award recognizes SNA of SC members and Industry members who make distinguished contributions to and for Child Nutrition Programs. Nominee should be someone who regularly lends his/her experience, expertise, and efforts to improve School Nutrition in South Carolina and is actively involved in the SNA of SC.

Judging for the Hall of Fame will be based on the following criteria:

The recipient of this award is a person who gives his/her time, talent, and energy unselfishly, making essential and recognized contributions, and is involved in civic or community service projects.

The Child Nutrition employee/Industry member should be someone who provides stellar customer service to students, staff and districts; going beyond their job duties to ensure customer concerns are addressed.

The Child Nutrition employee nominee should be actively involved in the SNA of SC and attend SNA of SC sponsored trainings, conferences, and activities. Current membership will be confirmed by SNA of SC Executive Director.

The nominee must have a minimum of 20 years of service in Child Nutrition Programs.
